

## To households exempt from resident tax

# Information on the FY 2023 Emergency Relief Benefit for Soaring Electric, Gas, and Food Prices

- A benefit to support households with unexpected downturn in household finances from January to September 2023.
- To receive the benefit, **procedures are required**.

## Amount of Benefit

30,000 yen (Only one benefit per household)

## Eligibility and Process

Households eligible for the benefit: (if one of the following applies)

A household in which all members are **resident tax exempt in FY2023**

Households which had an income decrease from January to September 2023 **equivalent to that of resident tax exempt**

An application form will be sent from the Niigata City Relief Center for Soaring Prices

\*Application forms will be sent to households which are registered residents of Niigata City as of June 1, 2023. Some households can receive the grant without applying.

### An application is required

**Application period:**  
from **July 24 (Mon.), 2023**  
to **October 31 (Tue.), 2023**



Households which are registered residents of Niigata City at the time of application are eligible.

# Application Procedures

## I Households exempt from resident tax in FY2023

- Eligible households will receive an application form from the Niigata City Relief Center for Soaring Prices, which includes information about the benefit and some items to confirm.
- Check and confirm the contents before you **send it back** to the Niigata City Relief Center for Soaring Prices using enclosed return envelope.

【Check the following】

- ① Whether or not there is any mistake in the bank account information to receive the benefit.
- ② Households with only dependent(s) of a person subject to resident tax are NOT eligible.

\*Households which received the FY 2022 Emergency Relief Benefit for Soaring Electric, Gas, and Food Prices can receive this year's benefit without submitting an application.



## II Households with unexpected downturn in household finances

**The income amount of the household decreased suddenly and as a result, each member's status became equivalent to that of resident tax exempt\***

\*Equivalent to resident tax exempt means that each member of the household has an estimated annual income (calculated by multiplying any one of the monthly earnings from January 2023 by 12) that is equivalent to or less than the resident tax exempt threshold

<Example> The annual income amount required to be eligible for resident tax exemption  
Single-person households: 965,000 yen or less annually; Two-parent, one-child households: 1,469,000 yen or less annually

- To receive the benefit, **procedures are required**.
- Fill out the application form and submit it to the Niigata City Relief Center for Soaring Prices by post along with any other necessary documents.



If you apply for this benefit based on a monthly income which was anticipated in advance to decrease, you may be charged with fraudulent benefit receipt (fraud).
